### How to Qualify for Club Membership

To become a Member of the Club, you need to own a Monaro, or you may join as an Affiliate Member whereby you must own a General Motors manufactured vehicle (either Australian or American). All Affiliate Members have the same rights and privileges as Monaro Members.

Please note that payment of Club Membership fees via EFT/Direct Debit does not deem Membership is accepted. Membership acceptance is at the discretion of the Club Management Committee. Fees paid by EFT/Direct Debit may be refunded via cheque refund where a Membership is not accepted.

### Club Outings

The Monaro Club of Qld Inc is a family based Club in which the whole family of Club Members is encouraged to get involved. There is one (1) Club Outing per

calendar month. These Club Outings are often to many different locations on the Gold Coast, Sunshine Coast and the east and west of Brisbane. Club Outings are also sometimes with other Local Car Clubs.

### Monthly Club General Meetings

The is a monthly Club General Meeting typically on the second Wednesday night of each calendar month at the Beenleigh and Districts Senior Citizens Centre. The meetings usually start at 7.30pm. The January Meetings are on the third Wednesday night of January.

### Club Magazine

A monthly Club Magazine is published and it contains information on upcoming Events, as well as general interest items on the Club. For Sale and Wanted Classifieds are also in the Club Magazine. There is no Club Magazine for December or January.

## Constitution.

### 1. The Name of Club:

shall be the "Monaro Club of Qld Inc",

### 2. Objective:

To bring together persons with a common interest, mainly the preservation of all model Monaros.

To publish a newsletter, containing technical information, words of encouragement, items of interest, list of spare parts wanted and for sale.

To conduct monthly meetings.

To encourage membership.

### 3. Officers:

The elective officers of this Club shall be the President, Vice President, Secretary and Treasurer.

Together they shall constitute a committee.

Additional office bears shall assist the committee members in all aspects of the Club duties if so desired.

### 4. Duties of Officers:

- i) The President shall preside over all the meetings at the Club, appoint all special committees as necessary to carry out activities of the Club, and will give guidance and leadership at all times.
- ii) The Vice President shall perform the duties of the President in his/her absence.
- iii) The Secretary shall keep the minutes of the meeting of the Club, keep membership records, give notice of all regular and special meetings of the members and the committee, handle all correspondence, keep

custody of all records and equipment of the Club.

- iv) The Treasurer shall collect dues, collect all other money due to the Club, keep the Club books, make payment from Club funds when so ordered by the committees, shall counter sign all Club cheques, keep account of all Club money matters and shall make regular reports of the financial condition of the Club.

### 5. Subscription:

Subscriptions shall be \$55.00 per member or family per annum and shall be payable prior to membership. All membership shall be due and payable on or before the first (1st) day of January each year. Family membership shall comprise of husband, wife, spouse or nominated partner and children up to sixteen (16) years of age. Any member who, after one (1) month has elapsed since payment of fees was due, has not paid his/her fees, and shall be suspended from membership until full payment is made. The Club fees will be revised annually and decided upon at the Annual General Meeting. Acceptance of all Applications for Membership is at the absolute discretion of the committee and may be denied or revoked at any time.

### 6. Affiliation:

The Club may recognise individuals who wish to affiliate with the Club, but do not strictly fit the requirements of the Club.

They will be known as Affiliate Members, and they will be entitled to voting privileges and subject to the approval of the committee. Affiliates are individuals who own Australian and/or American General Motors produced vehicles, which are not Monaros.

The dues of the affiliated members of this Club shall be the same as those for Club subscription.

The number of affiliated members shall be no more than Forty percent (40%) of Club membership numbers.

Affiliated members are to be nominated by a current member and seconded and approved at a committee meeting.

### 7. Elections:

- i) All nominees for office shall be active members.
- ii) All elected and appointed office bearers must remain active during their term of office.
- iii) Nominations shall be made from the floor and all voting shall be done by show of hands
- iv) Elections shall be decided by majority vote of all active members.

### 8. Quorum:

At an Annual General, or Special meeting, a quorum shall be five (5) members present, and at a committee meeting four (4) members present.

### 9. Annual General Meeting:

The second General Meeting after the thirtieth (30th) day of June shall be the Annual General Meeting. The Annual report and balance sheet will be presented at this meeting, being August.

### 10. Notice of Meeting:

Notice of meeting, or intention to convene a meeting, shall be given by the Secretary to all members. Monthly meetings held on the Second (2nd) Wednesday of each month, unless advised otherwise by the Secretary.

### 11. Limited Club Registration:

Shall only be available free of additional charges to Club members who have been active members for a period of three (3) calendar months. Limited Club Registration is available to new Club members, and non-active Club members; for an additional one off charge of \$60.00. This additional charge is further to Club membership fees. All Limited Club Registration Members are to remain active members thereafter, to maintain their Limited Club Registration.

### 12. Dissolution:

The Club shall dissolve in the event of the membership being less than four (4) persons, or upon the vote of the majority of the members present at the Special Meeting convened to consider such a question.

Upon dissolution, assets and funds on hand may, after payment of all expenses and liabilities, be handed over to a registered charity.

13. Club Members are to refer to the Club's "Model Rules" for further details on the functions of the Club, under it's Incorporated Association status.
